Audit Manager

Job ID: 104961

Job Description: This position exists to manage financial statement audit(s) and agreed upon procedures of government agencies in New Mexico in a timely and professional manner. This position is expected to produce quality audit work papers for more complex areas within budgeted time and successfully supervise and train staff on the engagement. This position performs and supervises audit report reviews to help ensure quality audit reports are released by the office. This position also leads and/or participates in teams to perform quality control reviews of financial working papers completed by Independent Public Accountants (IPAs). This position trains staff members and collaborates with co-workers and customers. This position may perform additional assignments as needed by the OSA, such as projects for the Governmental Accountability Office or Special Investigations Division.

Minimum Qualifications: Must possess and maintain an active New Mexico license as a Certified Public Accountant (CPA) or apply for a reciprocal New Mexico CPA license if the CPA license is from another state or territory (other than Puerto Rico or the Virgin Islands, which do not qualify) and six (6) years of experience conducting financial audits and attestation engagements, including four (4) years of supervisory experience.

Special Investigations Director

Job Description: This position will manage six employees in the Special Investigations Division. This position is responsible for performance of complex financial statement audits of government agencies, special audits, agreed upon procedures and other attestation engagements and the regulation of Independent Public Accounts (Firm Profiles). The incumbent in this position applies the appropriate American Institute of Certified Public Accountants (AICPA), Statements on Auditing Standards, U.S. Government Accountability Office (GAO) generally accepted Government Auditing Standards (Yellow Book Standards) and U.S. Office of Management and Budget (OMB) Circular A-133 (Single Audits) standards.

Minimum Qualifications: Must possess and maintain an active New Mexico license as a Certified Public Accountant (CPA) or apply for a reciprocal New Mexico CPA license if the CPA license is from another state or territory (other than Puerto Rico or the Virgin Islands, which do not qualify) and six (6) years of experience conducting financial audits and attestation engagements, including four (4) years of supervisory experience.

Compliance/ Regulation Director

Job Description: This position assures that the Office of the State Auditor (OSA) is aware of and implementing the most current technical standards and best industry practices in the field of government accounting and auditing. This includes substantive review of the applications submitted by accounting firms that wish to perform government audits, annual revision of the OSA's regulations consultation on complex standard-based issues and maintenance and revision of OSA policies regarding audit report review, work paper review and other financial division activities.
